






Introduction to Gambling & Gambling Disorder



Defining Terms



Gambling: Act of risking something of value on an event that is determined by chance.

- In MA: lottery, racing, keno, slots parlors, scratch tickets, casinos, sports betting
- Also includes activities like: betting on a card game with friends, betting in an office pool, raffles, bingo

Gambling Disorder: DSM-5 diagnosis.

Problem Gambling: Subclinical cases and clinical diagnoses of Gambling Disorder.



The Experience of Gambling Harm



- People continue to gamble despite bad consequences
 - Financial problems, relationship problems, legal problems or imprisonment, not fulfilling work or home duties, poor work performance or job loss, poor general health, poor mental health
- People feel a loss of control over gambling
- People experience craving or compulsion to gamble

Screening for Gambling Disorder



What is Screening?

Screening: A structured process to identify people whose gambling behaviors may lead to Gambling Disorder or gambling-related harms.

- First step of the treatment process.
- Screening tools are not diagnostic.
- Screening isn't just for clinicians Anyone can screen for Gambling Disorder!





Why Screen for Gambling Disorder? (1/2)

- 2% of Massachusetts adults are currently experiencing problems with gambling – estimated between 83,000 and 135,000 people!
 - An additional 8% of Massachusetts adults are at-risk gamblers
- Many cases of Gambling Disorder go undetected and untreated.
 - A national survey found that 49% of individuals with gambling-related problems reported receiving treatment for one or more mental health concerns, but none received treatment for gambling
 - Worldwide, the treatment-seeking rate is less than 10%



Why Screen for Gambling Disorder? (2/2)

- Individuals experiencing a Gambling Disorder are at much higher risk for having substance use or other mental health problems
- Individuals experiencing a Gambling Disorder are at increased risk for suicidal ideation, suicide attempts and mortality, and non-suicidal self-harm
- Unaddressed gambling problems may contribute to poor treatment outcomes, increased utilization of treatment resources, and higher costs



Brief Biosocial Gambling Screen (BBGS)

- Brief screener with 3 yes/no questions
- Scoring: "Yes" to any question is considered a positive screen; indicates potential gambling-related problems and the need for additional evaluation
- Used successfully with veterans, college students, and among those in treatment for a substance use or mental health problem

- 1. During the past 12 months, have you become restless, irritable, or anxious when trying to stop/cut down on gambling?
- 2. During the past 12 months, have you tried to keep your family or friends from knowing how much you gambled?
- 3. During the past 12 months, did you have such financial trouble as a result of your gambling that you had to get help with living expenses from family, friends or welfare?



Best Practices for Screening for Gambling Disorder

- Start by defining gambling.
- Open the conversation by asking:
 - "How often do you..."
 - Buy lottery tickets?
 - Play cards for money?
 - "Have you ever..."
 - Bet on sports?
 - Played slot machines?
- Don't only ask "do you gamble?"

- Don't make assumptions about the client's gambling behaviors.
- Be welcoming and nonjudgmental to minimize defensiveness and resistance.
- Anticipate the client might feel guilty about disclosing their gambling history.



Steps Following A Positive Screen

- Conduct a full assessment or refer the individual to someone who can
- Have resources identified ahead of time
- Explain that a positive screen does not mean they have Gambling Disorder





Screening vs. Assessment

Screening: A process for evaluating the possible presence of a particular problem. The outcome is normally a simple yes or no.

Assessment: A process for defining the nature of that problem, determining a diagnosis, and developing specific treatment recommendations for addressing the problem or diagnosis.





DSM-5 Criteria for Gambling Disorder

- 1. Risks increasing amounts of money to reach desired excitement
- 2. Irritable or restless when attempting to cut back or stop
- 3. Unable to cut back, control, or stop gambling
- 4. Pre-occupied with gambling
- 5. Often gambles when feeling distressed (e.g., depressed)
- 6. After losing money, returns to get even
- 7. Lies to conceal the extent of involvement with gambling
- 8. Risks or loses relationships or jobs because of gambling
- 9. Relies on others for financial needs
- ? Continuous or episodic and recurrent.
- ? Symptoms are not better explained by Bipolar Disorder.

Persistent and recurrent problematic gambling behavior leading to clinically significant impairment or distress

4+ symptoms in a 12-month period = Gambling Disorder

Gambling Disorder Screening Day

- International grassroots event to increase awareness of gambling harm and educate and support providers and others to screen for Gambling Disorder
- Annual event held on the second Tuesday of March (PGAM)
- 2023: At least 180 individuals and organizations participated, representing 34 U.S. states and 7 countries

Objectives of Screening Day

- **Inform** providers and others in the community about the importance of screening for this treatable but often unrecognized condition.
- Educate providers and people who gamble about the nature of gambling-related problems and Gambling Disorder, and to educate providers and others about how to screen for it.
- Identify people who may be experiencing gambling-related harms through the act of screening.
- Connect people who may be experiencing gambling-related harms with additional resources (helplines, self-help tools, fellowship, treatment).



How to Participate in Screening Day (1/4)

Hosts/Screeners: Individuals/organizations who screen people for Gambling Disorder on Screening Day (i.e., host a screening event)

- Administer screens to clients during appointments
- Hold drop-in screening sessions in your lobby or waiting room
- Hold virtual drop-in screening sessions
- Table in a community space to share information about Gambling Disorder and promote self-screening (faith-based institutions, libraries, grocery stores, etc.)
- Partner with other organizations to hold screenings (e.g., college campuses)

Be creative in your approach!



How to Participate in Screening Day (2/4)

Who can host an event?

 Anyone can host a Screening Day event! – Addiction and mental health service providers, physicians, recovery coaches, case managers, educators, community leaders/groups, corrections officials, educators, veterans' groups, etc.

When should I hold my event?

 Screening Day is Tuesday, March 12th – Host your event on this day, or any other day (or week) that works for you!



How to Participate in Screening Day (3/4)

What resources will I need to host an event?

- Screening Day Best Practices Guide
- Screening Day Toolkit
- The BBGS (or another validated gambling screener)
- Promotional and educational resources (e.g., swag box, MA Health Promotion Clearinghouse)
- Training and educational for event facilitators
- Other resources, depending on your event: space, personnel, etc.



Gambling Disorder Screening Day Toolkit

Free resources, educational materials, and information.

- Screening Day how-tos
- Brief Biosocial Gambling Screen (BBGS) – printable, electronic, and pocket screeners

How to Participate in Screening Day (4/4)

Other considerations:

- Have a procedure for how to handle positive screens and make sure your event facilitators know this plan.
- Do your event facilitators need additional education or information about Gambling Disorder and screening?
- Consider how you might promote your event (social media posts, promotional flyers, newsletter announcements, etc.)
- Don't forget to collect data during your event (e.g., number of positive screens) so that you can complete the post-event survey!



Required Activities/Deliverables for Awardees

Screening Day Host Awardee organization requirements

Getting Started

- Do the event facilitators need additional training or information to help prepare them to screen for Gambling Disorder?
- What resources will your event require? (Physical space? Promotional materials? Educational resources?)
- How and where will you promote your event? What will you need?


